Introduction

Document Overview

This document is intended to provide the QuickStart Client *and their named developers an overview of the QuickStart features and functionality together with full instructions and a series of complete XML Request and Response examples*

The reader will notice that responses to the same XML request message may vary based on the functionality of each CRS. An example of this is the structure of the Availability response, which although schematically correct, may differ slightly for some hotel chains.

Note: *The documents primary aim is to provide example transactions, and also demonstrate certain differences in responses between one hotel chain and another. It is by no means an exhaustive list of fields that can be returned by each CRS, as this may vary based on the rate, room, type of rate, booking conditions etc. The developer is asked to consult and code based on the published UltraDirect Schemas.*

Property Download Site

The Property Download Site (PDS) is accessed via a Portal and allows access to the list of properties that are available in the DHISCO Content in production. DHISCO will provide instructions on how to access this site as soon as all is prepared on our side:

- **An Up-to-Date list of QuickStart available brands will be provided as part of the implementation.**
- The “Agreed Download HCD prop List.zip” is updated on the PDS site on a daily basis and can be used to identify properties that have recently updated their data (UPDATE_DATE)
- Agreed Download Brand List.zip is for the hotel brand code detail

Accessing DHISCO QuickStart

System Access

The UAT (User Acceptance Test environment) URL where messages will be posted to during the development and certification phase is:

http://ud-uatprod.dhisco.com:5454/apps/TransactionInterfaceV1_1/DispatcherServlet

The Production URL will be provided by the DHISCO project team once all initial testing and certification is completed. DHISCO uses your IP addresses as a way of allowing/denying traffic into our environment. The first validation is done at the web server, where a set of Access Control Lists must contain your IP(s) in order to allow you into our boxes. If your IP(s) do not exist, you will receive an error to the effect of:

"Server Error"

IP:

The next validation is based on matching your IP(s) to the specific code (Source Code) that was assigned to each customer. This code uniquely identifies ExMarketPlace traffic and is passed in the Source attribute of the Route element.

Your Unique QuickStart Source Code (SGA) will be provided at the time of Implementation

For example, an example customer may have a Source code of "XX" and an IP of 123.123.123.123. There are potentially two ways to be denied:

1. If the example customer passes a code in the Source attribute other than "XX".
2. If the example customer generates the message from an IP that is not listed.

If you execute one of the two examples just listed, you will receive the following error:

Booking Storage and Retrieval

QuickStart does not store nor provide a transactional method to retrieve booking transactions from the Hotel systems.

Therefore, one of the requirements for this project is for the QuickStart Client to store all booking information on their local servers. It is also suggested that raw XML transactions are logged and stored as part of the customers booking.

The minimum information needed to to Cancel and/or resolve Customer Service queries is: Guest Details, In Date and Out Date and Confirmation Number. It is also advisable to store all policy related information, for example Cancel Details, Guarantee Policy etc.
